All goods must be family oriented. **Products to be sold must be approved by the Taos County Fair Board Association prior to the start of the Taos County Fair.** Obscene pictures, language, or materials considered offensive or disruptive will not be allowed. We are trying to prevent booths from duplicating too much of the same food/products to be sold at the fair.)

**Commercial Booth Rental: Space 10' x 10'**

Commercial Booth Fee: \$75.00/Day or \$125.00/2 Days

**Commercial Food Vendor Booth Rental: Outdoor Space 20' x 20'**

Commercial Food Vendor Fee: \$150.00/Day or \$275.00/2 Days

(Food Vendors are responsible for obtaining a Temporary Food Vendor Permit from the New Mexico Department of Environment. The permit is required to be displayed at the booth during the fair.
